PROFILE

Antonios Papadimitropoulos is an Assistant Professor of Civil Law at the University of Athens, Faculty of Law and has been an Attorney at Law since 2000. He completed his undergraduate studies at the University of Athens (1998) and his postgraduate studies in Civil Law at the University of Freiburg, Faculty of Law (2000). He obtained his PhD at the University of Freiburg (2006) submitting his PhD thesis on “*Contractual relations with protective effect in favor of third parties under German law*” (Schuldverhältnisse mit Schutzwirkung zugunsten Dritter im deutschen Recht). His main research area is Civil Law.

Antonios Papadimitropoulos teaches Contract Law, Inheritance Law and Advanced Lessons of Civil Law in the undergraduate course of studies as well as contractual formation and liability under comparative perspective in the postgraduate course of studies. He is the author of monographs and articles published in law journals and collective works in Greek, German and English.
