Vasilis Triantafyllidis is Assistant Professor of Civil Law at the Faculty of Law of the National and Kapodistrian University of Athens. He has also obtained an LL.M. and a PhD from Freie Universität Berlin (Germany), both under the supervision of Prof. Dr. iur. Dr. rer. pol. Dres. h.c. Franz Jürgen Säcker. He teaches General Principles of Civil Law, Law of Obligations, Property Law and Advanced Lessons on Civil Law in the graduate program and Energy & Civil Law in the postgraduate program of the Faculty of Law of the National and Kapodistrian University of Athens. His research interests include contract and tort law, property law, succession law, European private law, as well as energy and competition law.
